IMPORTANT INFORMATION:

PLEASE NOTE: We do not send bills for dues payment.

The dues of all members shall be paid <u>monthly</u>, <u>quarterly</u>, or <u>annually</u> but always in advance.

Your union dues must be received in our office no later than 5:00 pm on the last day of the month for the following month if mailed; the envelope must be postmarked by the last day of the month, to protect your membership and eligibility for employment.

Failure to pay dues within **three (3) months** shall result in automatic <u>SUSPENSION</u>; and a reinstatement fee of \$50.00 being assessed without notice of any kind. (According to applicable provisions of the United Association Constitution, Suspension of Members, SEC. 157)

Failure to pay dues within **six (6) months** shall result in automatic **EXPULSION**. (According to applicable provisions of the United Association Constitution, Expulsion of Members, SEC. 159)

REINSTATEMENT

The Reinstatement Fee is fifty dollars (\$50.00), in addition to the Reinstatement Fee, be required to pay all back dues not to exceed six months (6) months. No partial payment accepted; payment must be made in full remitted to UA Local 345.

RETURNED ITEM:

There is a fee for returned or cancelled checks, responsibility of the member.

UNITED ASSOCIATION (BENEFICIARY OF BURIAL EXPENSE)

Burial Expense Benefits for Members
